- LEGISLATION
 - Sufficiently progressive legislation
 - Some incompatibility between the constitution/legislation and international standards
 - Human rights approach to legislation needs to be reinforced
- INSTITUTIONS
 - PIC problematic
 - Deficit number of prosecutors/judges in the country
 - Human rights training needs to be reinforced
- PRE- TRIAL DETENTION IN PRISON
 - Not respected legal frames
 - Overcrowding
 - Problematic access to health care
 - Lack/insufficient independent mechanisms of complaints




- Mozambique has ratified most of the treaties

- Progressive legislation on the matter;
- Good practices that should be reinforced on the prevention of the criminality (e.g social activities in the neighbors by NGOs; use of community courts for minor cases);
- For children with no criminal responsibility, juvenile courts has no places for reintegrate and reeducate children in the country. Judges rely on the family, most of the time dysfunctional. A program financed by UNICEF is trying to create programs to support kids.
- For children with criminal responsibility we have the same issues for adults, plus the fact that often these kids are not treated as kids, but rather as adults (there is a way to say...if the kid has a beard his not a kid anymore);
- Mozambique need the "famous" strategy for preventing criminality. Juvenile courts as the one in Maputo should be replied in the all country (for children with no criminal responsibility). Courts for juveniles and family matters should be created (for juveniles with criminal responsibility) with a all process of restructuring the system and train specialized personnel. The role of NGOs and community courts is important.






- Detainees are found economically assisting families
